# Art has the power to move, educate and connect us.

At its heart, Essex County Community Foundation is a leader, bringing together people and organizations from all corners of Essex County to strategize on the best ways to improve the quality of life in our region. Because we serve the whole County – all 34 cities and towns – ECCF has the knowledge and the capacity to foster meaningful connections between philanthropists, nonprofit organizations and state and local community leaders, and spearhead initiatives that inspire collective action.

We believe that by working together as one, we can acheive our goal: that Essex County has a strong ecosystem for arts, culture, design and creative enterprise that is both equitable and accessible.

# **CREATIVE COUNTY INITIATIVE**

On April 13, 2018 at our inaugural Arts & Culture Summit, ECCF publicly unveiled its Creative County Initiaitve, the first ever comprehensive countywide effort to elevate arts and culture in the region.

More than 400 artists, art and cultural nonprofit representatives and community leaders gathered at The Cabot, Beverly's historic and beloved arts and performance center, for a high-energy day of education, networking and live performances.



Local and international experts spoke on the power that creative placemaking, public art and cultural planning has to transform communities, promote inclusion and celebrate diversity. And ECCF unveiled the following key components of our Creative County Initiative.

Our Creative County grants\* program for

public art and creative placemaking is a \$300,000 investment in 11 collaborative arts and culture projects across Essex County that encourages broad community support for the arts and cultural assets that make our communities vibrant and diverse.

The creation of an online arts hub – **EssexCountyCreates.org** – that connects the arts and culture community directly to the public with a comprehensive regional online arts and culture calendar. The site also includes valuable resources for the arts and culture community. More than 150 artists, organizations and venues have already joined the site and over 1,000 events are posted.

#### Resources for cultural planning are

underway with the Metropolitan Area Planning Council and the Merrimack Valley Planning Commission to bring cultural planning to every Essex County community. CCI's Cultural Planning programs will provide a road map for the future of arts and culture in Essex County. We will deliver a regionalized approach to creative placemaking, public art, arts and culture policy, regional cultural exchange, and greater investment in arts and culture by the county's philanthropic leaders.



# Taking on Essex County's Greatest Social Challenges

Imagine a time when all people who live, work and raise families here in Essex County are happy, healthy and thriving. This is the long-term goal of Impact Essex County, ECCF's community leadership project aimed at improving the quality of life in the 34 cities and towns of Essex County.

In 2018, ECCF made significant headway towards making this vision a reality. We started the year by taking a deep dive into eight of the region's most pressing social issues, as identified in 2017 through a thorough analysis of published data collected at ImpactEssexCounty.org.

# TIMELINE

### 2016:

JANUARY: A key leaders forum to advise on ECCF's Indicator project was initiated.

**APRIL-OCTOBER:** Focus Groups helped identify 100+ indicators to measure.

**OCTOBER:** ECCF launched a new data website at a 250-person event, led by Salem Mayor, Kimberley Driscoll.

**DECEMBER:** ECCF media campaign promoted data website for use by the community.

## 2017:

JANUARY: ECCF Advisory Council analyzed 100 indicators, identified challenges facing our county, and prioritized the top eight greatest challenges.

**APRIL-NOVEMBER:** Meetings conducted to gain greater knowledge about each challenge area, narrowing to three for further research.

**DECEMBER**: ECCF Trustees (with help from Advisory Council) selected the first Impact Essex County systems change project: Empowering Economic Opportunity.

16<sup>%</sup> INCREASE IN CHILDREN LIVING IN POVERTY FROM 2010-2014 126<sup>%</sup> INCREASE IN RATE OF HOMELESSNESS SINCE 2007 With the help of ECCF's dedicated Impact Essex County Advisory Council and panels of community, state and nonprofit representatives - those closest to Essex County's most critical needs - in early 2018, those eight challenges were narrowed to three. Then, after careful consideration, ECCF trustees, working alongside the IEC Advisory Council, selected the first Impact Essex County initiative: Empowering Economic Opportunity. We know that by creating better access to economic opportunities, residents of Essex County will feel empowered to lead more financially secure, fulfilling and productive lives.

But how do we do this?

By spring 2018, ECCF's Collective Impact model of systems change had taken shape. The idea is that by working together, not only can we ease the symptoms of the social challenges we face, but we can also address their underlying causes. By strengthening the links between nonprofits, community leaders and funders – i.e. changing the system – we can create a more engaged, collaborative approach to philanthropy that will result in greater impacts on the obstacles that impede a high quality of life for all.

By the end of the fiscal year, Impact Essex County's first three-year project grew legs, and with the selection of four key programs to carry out our goals, the path to a higher quality of life for those who live, work and raise families in Essex County was paved.

### 2018:

**MARCH:** ECCF shaped its Collective Impact model of systems change.

**JUNE:** IEC's first three-year project took shape and four key programs were selected.

**SEPTEMBER:** ECCF developed business and fundraising strategy for Impact Essex County's long-term impact.

### 2019:

JANUARY – FEBRUARY: ECCF will announce its first threeyear project, Empowering Economic Opportunity, and its partners.

The Essex County Funders Summit provides a forum for philanthropists from across the region to engage in open discussion, networking and resource sharing. Our private foundation friends had the chance to inform each other on their giving strategies. And ECCF's individual fundholders shared with each other their philanthropic interests and causes they support.

Our 2018 honorees – David McKechnie of Beauport Financial and The Women's Fund of Essex County – are true examples of people and organizations "Doing Together What We Cannot Do Alone."

"At Beauport Financial, we are having conversations with our clients not only on return on investment, but also return on their lives," said McKechnie, who received the 2018 Professional Advisor Award. McKechnie has a long list of philanthropic credits to his name, including his role as chair of ECCF's Professional Advisors Committee, lonatime involvement with the YMCA of the North Shore and his firm's Richard D. Wilson Community Response Gift Fund, managed by ECCF.

The Women's Fund of Essex County – an ECCF field of interest fund – was awarded the 2018 George Peabody Award for its impact on the health and wellbeing, economic self-sufficiency and security, and leadership and empowerment of women and girls. Since its inception in 2003, The Women's Fund, an all-volunteer organization, had awarded nearly \$2 million to 100 Essex County nonprofit programs.

## 9TH ANNUAL INSTITUTE FOR TRUSTEES

Each year, Essex County Community Foundation brings nonprofit leaders together for an exciting day of workshops, idea sharing and networking at our annual Institute for Trustees, recognized as the region's leading educational conference for nonprofit board members and executive directors.

# At the 9th Annual Institute for Trustees, **'Everyone Leads'** Social Change.





On March 24, more than 350 nonprofit leaders gathered at the Pingree School in South Hamilton for the 9th Annual IFT, where keynote speaker Paul Schmitz, CEO at Leading Inside Out and senior advisor at The Collective Impact Forum, discussed Collective Impact, a 2018 focus of ECCF's community leadershp work.

During his talk, Schmitz told the story behind the Montgomery Bus Boycott. But it was not the prepackaged version many of us may remember from history class: the story about one woman who refused to give up her seat on the bus and started a boycott that sparked a national movement. Instead, it was the collective story, created by many, that led to a turning point in our history.

Yes, it was about Rosa Parks and Dr. Martin Luther King. Those are the names you've heard. But it was also about E.D. Nixon and Ella Baker and Fred Gray and Clifford and Virginia Dunn, Ralph Abernathy, and many, many others who all had a critical role in the Boycott.

"Everyone led," he said. "That's Collective Impact."

Conference attendees were clearly energized by Schmitz' talk as they readied for the rest of the day, which included more than 20 workshops in board development, strategic planning, financial management and development, a lunch update of Essex County Community Foundation's Community Leadership Initiatives and a cocktail reception to wind things down.

"I think some of the conversations about collaboration start here," said Susan Hauck from Marblehead Community Charter Public School. "We're lucky to be able to have ECCF."




